

ORDINANCE NO. 4561

AN ORDINANCE AMENDING ORDINANCE NUMBER 4329, ADOPTED JUNE 19, 1998, GRANTING A CONDITIONAL USE FOR A PLANNED DEVELOPMENT

(PC 98-34: Highland Estates (Providence))

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois; and,

WHEREAS, on June 19, 1998, the President and Board of Trustees adopted Ordinance 4329, granting conditional use for a Planned Development for the property legally described in Section 2; and,

WHEREAS, Title 15, Chapter 155, Section 155.504 allows for amendment of an ordinance granting a conditional use for a Planned Development after a public hearing before the Village's Plan Commission; and

WHEREAS, pursuant to an application to amend Ordinance 4329, proper and legal notice was provided and a public hearing was held before the Village's Plan Commission on October 19, 1998; and

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the amendment described herein; and,

WHEREAS, the President and Board of Trustees approve and adopt the findings and recommendations of the Plan Commission and incorporate such findings and recommendations herein by reference as if they were fully set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Page 2

SECTION 1: That the third Whereas of Ordinance 4329 be amended to change the number of permitted lots from 83 to 87.

SECTION 2: That Section 3, Condition 1, shall be amended to read as follows:

1. The site shall be developed in substantial compliance with the Site Plan of Highland Estates Development, Amendment to Highland Estates P.U.D., prepared by the Balsamo/Olson Engineering Company, dated October 7, 1998, except as modified herein.

<u>SECTION 3</u>: That the following conditions be added to Section 3:

- 15. That aerators be provided for the retention ponds in Outlots "A" and "C".
- 16. That a viewing area be provided between 16th Place and Outlot "A" overlooking the retention pond, with the design of the viewing area to be worked out with Village staff and with final approval to be granted by the Community Development Director.

SECTION 4: That this ordinance is limited and restricted to the property legally described as follows:

LOTS 1 THROUGH 26 AND LOTS 28 THROUGH 82, OUTLOTS A, B AND C, AND ALL THE STREETS (16TH PLACE, 17TH STREETS, 17TH PLACE AND LALONDE AVENUE) IN HIGHLAND ESTATES SUBDIVISION, BEING A SUBDIVISION OF PART OF THE EAST HALF OF THE SOUTHWEST QUARTER AND PART OF THE WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 20, TOWNSHIP 39 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED DECEMBER 23, 1997 AS DOCUMENT R97-199127, IN DUPAGE COUNTY, ILLINOIS.

ALSO:

LOTS 2 AND 3 IN THOMAS RESUBDIVISION, BEING A SUBDIVISION IN THE WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 20, TOWNSHIP 39 NORTH, RANGE 11 OF THE THIRD PRINCIPAL MERIDIAN.
