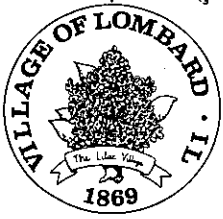

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entries relative to the Class K liquor license category, contained therein to read as follows:

Class "K" – 2

Section 2: That the change in the number of Class K liquor licenses set forth in Section 1 above, is a result of granting a liquor license to Shakti05 Restaurant Inc. doing business as Haveli located at 530 E. North Avenue, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
