**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended, by revising the entry relative to the Class "C" liquor licenses contained therein, to read as follows:

Class "C" – 9

Section 2: That the change in the number of Class "C" liquor licenses set forth in Section 1 above, is due to Omega Lombard by Gail, LLC d/b/a Gail's Carriage Café located at 2300 S. Highland Avenue voluntarily not renewing their liquor license.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
