Elizabeth St., that commuters are parking on Elizabeth St. between Grove St. and Windsor Ave. To remain consistent with area parking time limits, staff recommends posting the east and west side of Elizabeth St. between Grove St. and Windsor Ave. "1 HR Parking, 7 am-10am, Except Sundays and Holidays". Attached is a signed petition from area neighbors in favor of this change.


I would appreciate any assistance I can receive from the Village in having 1 hour signs (from 7am to 10am) posted either on my property or the entire street.
