Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code Omega Restaurant/Gail's Carriage Café – 2300 S. Highland Avenue

Omega Restaurant located at 2300 S. Highland Avenue currently holds a Class "C" liquor license which allows consumption of beer and wine on the premises of a restaurant. Omega Restaurant has been sold and the new owners, Omega Lombard by Gail, LLC d/b/a Gail's Carriage Café', is requesting the same classification of liquor license. As of this writing, the new owners have been in operation since June 25 but have not been serving alcohol.

Attached is an ordinance decreasing and increasing the entry in the Class "C" liquor licenses by one to reflect the termination of Omega's liquor license and issuance of a liquor license to Gail's Carriage Café.

Staff is requesting a waiver of first reading to accommodate their request and the Village Board's summer schedule.

ORDINANCE	

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 7

This decrease in the number of Class "C" liquor licenses reflect the termination of the Class "C" liquor license issued to Omega Restaurant Ltd. d/b/a Omega Restaurant located at 2300 S. Highland Avenue due to the sale of the restaurant and new ownership.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 8

This increase in the number of Class "C" liquor licenses reflects the issuance of a new Class "C" liquor license to Omega Lombard by Gail, LLC d/b/a Gail's Carriage Café located at 2300 S. Highland Ave., Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
