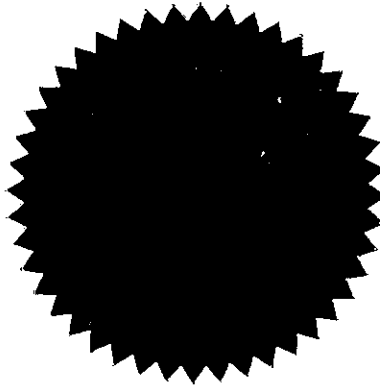

ORDINANCE 5013

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

| Name of Street | Shall Stop At | Name of Street |
|---------------------------|---------------|------------------|
| Fairfield Court | " | Fairfield Avenue |
| Rosebud Drive, northbound | " | Fairfield Avenue |
| Rosebud Drive, southbound | " | Fairfield Avenue |
| 18 th Street | " | Fairfield Avenue |
| Graywood Drive | " | Fairfield Avenue |
| 17 th Street | " | Fairfield Avenue |

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

| Name of Street | From | To |
|----------------------------|---------------------------------|-----------------------|
| Madison Street, south side | West curb line of Edgewood Ave. | A point 100 feet west |

Section 3: That Schedule I of the Lombard Traffic Code (Ordinance 1186) entitled ALTERED MAXIMUM SPEED LIMITS be amended to add the following thereto:

| Name of Street | From | To | Max Speed |
|----------------|----------------|-------------|-----------|
| Madison Street | Addison Street | Finley Road | 25 MPH |

Section 4: That Schedule I of the Lombard Traffic Code (Ordinance 1186) entitled ALTERED MAXIMUM SPEED LIMITS be amended to delete the following therefrom:

| Name of Street | From | To | Max Speed |
|----------------|-------------|-------------|-----------|
| Madison Street | Main Street | Finley Road | 30 MPH |

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.






