The Village of Lombard Board of Trustees hereby provides notice that a public hearing will be conducted to repeal Ordinance No. 6111 and to adopt a new Annexation Agreement providing for the annexation of the property to the Village of Lombard immediately following contiguity between the Village corporate limits and the subject property as well as granting a conditional use for an existing religious institution.

As you will recall, you were previously notified of actions associated with the 1420 S. Meyers Road address. The Lombard Board of Trustees approved those actions on November 1, 2007 through Ordinance No. 6111. The petitioner is now requesting minor modifications to the recently approved Annexation Agreement (Ordinance No. 6111). These modifications together with Village staff including the address range used for the subject parcels warrants a new public hearing and we are notifying you of the same.
