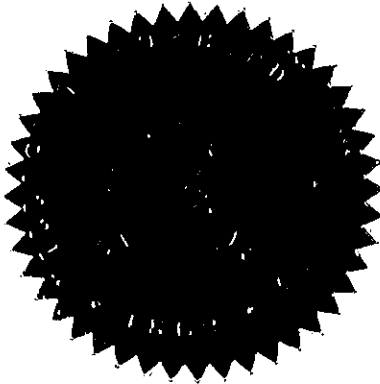

ORDINANCE NO. 4649

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

| <u>Name of Street</u> | <u>From</u> | <u>To</u> |
|-----------------------------------|----------------------------------|-----------------------|
| Kelly Court East and West side | curb line of Washington Blvd. | a point 45 feet south |
| Berkshire Ave. North side | East curb line of Main Street | a point 285 feet east |

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following thereto:

| <u>Name of Street</u> | <u>From</u> | <u>To</u> |
|------------------------------|----------------------------------|---|
| Berkshire Ave. South side | East curb line of Main Street | a point 75 feet east of the west curb line of Charlotte |

Section 3: That Schedule XX (b) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING DURING THE HOURS OF 8:00 A.M. TO 4:00 P.M. ON SCHOOL DAYS be amended to add the following thereto:

| <u>Name of Street</u> | <u>From</u> | <u>To</u> |
|------------------------------|----------------------------------|-----------------------|
| Berkshire Ave. South side | East curb line of Main Street | a point 285 feet east |

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.




