TITLE: An Ordinance Amending Schedule XII of the Lombard Village Traffic Code in
Regard to Commuter Parking Lots and Fees

BACKGROUND/POLICY IMPLICATIONS:

Per the agreement with Elmhurst Memorial Healthcare, the North Maple Street Commuter Parking Lot will close to commuters effective August 1, 2004. Due to this change and the fact that Metra advises that all new commuter lots be operated as daily fee, Village staff recommends that the South Maple Commuter Parking Lot, currently a permit parking lot, be operated as a daily fee lot effective August 1, 2004.

In addition, effective August 1, 2004, the newly-constructed Hammerschmidt parking lot will open to commuters as a daily fee lot. This lot is located north of the railroad tracks on east St. Charles Rd. on the old Hammerschmidt property.

Due to the fact that the Village will begin a new commuter parking quarter on August 1, 2004, waiver of first reading is requested.

The attached ordinance reflects these changes.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XII (a) of the Lombard Traffic Code entitled PERMIT PARKING ZONES is amended to read in its entirety as follows:

In accordance with Section 10-13-22, municipal parking permits may be issued authorizing the parking of private vehicles in the municipally owned or leased properties described as follows.

Vehicles parked in those parking lots referenced in Schedule XII (a) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

St. Charles Road Commuter Lot and Park/Elizabeth Commuter Lot -

Quarterly Fee (3 month period) -	\$75.00 for residents and non-residents
If less than 60 days, but more than 30 days, left in the Quarter -	\$50.00 for residents and non-residents
If 30 days or less left in the Quarter -	25.00 for residents and non-residents

Section 2: That Schedule XII (b) of the Lombard Traffic Code entitled DAILY FEE PARKING ZONES is amended to read in its entirety as follows:

In accordance with Section 10-13-14, daily fee parking zones are described below. The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

East Parkside Avenue Lot: north side from Charlotte Street to Martha Street

West Parkside Avenue Lot: north side from Park Avenue to Elizabeth Street

DuPage Theatre Lot: south parking lot

Maple Street South Parking Lot: south side between the Lombard Historical Museum and the Calvary Episcopal Church

Hammerschmidt Lot: north parking lot on east St. Charles Road

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
