Attached pleased find a contract and resolution for the design engineering services for the Eisenhower Lane Reservoir Facility project.

As part of the short-list selection process, the Eisenhower Lane Reservoir Facility project was the target project for the Hydraulics and Hydrology Engineering Short-List. A total of eighteen (18) firms received the Request for Qualifications and Proposals. Seven (7) firms submitted qualifications and proposals for the Hydraulics and Hydrology Engineering Short-List and the Design Engineering for the Eisenhower Lane Reservoir Facility Project. After review, evaluation and rating of all seven (7) proposals by the five person selection committee, Christopher B. Burke Engineering, Ltd. of Rosemont was determined to be the most qualified firm for the design engineering for the subject project.

Negotiations were conducted to modify the scope of work and work effort to include the design of DuPage Water Commission's supply main and metering station. The contract award is a not to exceed amount of \$286,037.04.

Please present this agreement and resolution to the President and Board of Trustees for their review and approval at their regular meeting on June 3, 2004. If approved, please have both signed copies returned to Engineering for further processing.
