

ORDINANCE NO. 6150

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule I of the Lombard Traffic Code (Ordinance 1186) entitled ALTERED MAXIMUM SPEED LIMITS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>	<u>Max Speed</u>
Fairfield Ave.	Roosevelt Rd.	Wilson Ave.	30 MPH

Section 2: That Schedule I of the Lombard Traffic Code (Ordinance 1186) entitled ALTERED MAXIMUM SPEED LIMITS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>	<u>Max Speed</u>
Fairfield Ave.	Roosevelt Rd.	Madison St.	25 MPH

Section 3: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Madison St. South side	Westmore Ave.	a point 225 feet east

Section 4: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Madison St. South side	east curb line of Westmore/Meyers Road	a point 325 feet east

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
