

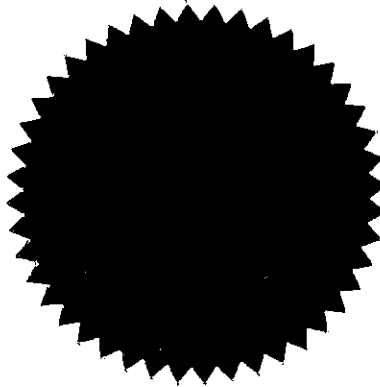

ORDINANCE 4881

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B-II liquor license, contained therein, to read as follows:

“Class A/B-II – 8”

Section 2: That the change in the number of Class A/B-II liquor licenses set forth in Section 1 above, is as a result of the cessation of business of Carson’s the Place for Ribs located at 400 E. Roosevelt Road, Lombard.

Section 3: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class C liquor license, contained therein, to read as follows:

“Class C – 2”

Section 4: That the change in the number of Class C liquor licenses set forth in Section 1 above, is as a result of the cessation of business of China Star Buffet & Grill located at 800 E. Roosevelt Road, Lombard.

Section 5: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


