BACKGROUND/POLICY IMPLICATIONS: Attached for your consideration are two ordinances amending Title 11 relative to providing an outdoor viewing event in the event the Chicago Blackhawks play in the 2015 Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup Finals. The first ordinance provides for the sale and consumption of alcohol in connection with a temporary event at 11 and 16 S. Park Avenue between May 9, 2015 and June 7, 2015. The second ordinance provides that a single permit be issued covering the 2015 Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup Finals. SUBJECT: Special Event Liquor Licenses for Punky's Pub and Shannon's Deli for the 2015

Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup

Finals

Given the possibility of the Chicago Blackhawks playing in the National Hockey League (NHL) Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup Finals, two ordinances have been drafted to allow for one outdoor viewing event of a mutually selected game (between the Village and Lombard Town Centre) that could provide for the sale and consumption of alcoholic beverages with the viewing event. The event would be similar in design and operations as the other outdoor viewing events in 2013 and 2014. The dates and times have not been set. However, as the Village Board will not meet again until May 21, 2015, staff is bringing this item forward for consideration at this time.

Attached are two ordinances to allow for one outdoor viewing event to be held on a mutually agreeable date between May 9 and June 7, but only in the event that the Chicago Blackhawks hockey team is playing in the game:

- 1. AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES, PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION WITH A TEMPORARY EVENT AT 11 AND 16 SOUTH PARK AVENUE, BETWEEN MAY 9, 2015 AND JUNE 7, 2015
- 2. AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.47(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO TEMPORARY EVENTS

Should the aforementioned Ordinances be approved, staff will work with the relevant parties (i.e., Punky's, Shannon's and Lombard Town Centre), to finalize the plans for any such viewing events.

Issues to be finalized include specific dates and times, event conflicts, Village staff labor/staffing, equipment availability, and outdoor space availability.

ACTION REQUESTED

This item is being placed on the May 7, 2015 Village Board consideration for consideration and approval. Staff recommends waiver of first reading.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B)
OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES,
PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION
WITH A TEMPORARY EVENT AT 11 AND 16 SOUTH PARK AVENUE,
BETWEEN MAY 9, 2015 AND JUNE 7, 2015

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code is amended by adding a new subsection (7) thereto, effective upon the adoption of this Ordinance through 11:59 p.m. on Sunday, June 7, 2015, which shall read in its entirety as follows:

"(7) In light of the fact that Shannons on Park, Inc. d/b/a Shannon's Deli, located at 11 South Park Avenue, and Bill and Punky's Step Up Inn, Ltd. d/b/a Punky's Pub, located at 16 South Park Avenue, will be holding one (1) temporary event for the viewing of one (1) Chicago Blackhawks Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup Finals, between May 9, 2015 and June 7, 2015, should the Chicago Blackhawks play on the above dates, said liquor licensees shall each be eligible for a Class "J" liquor license, despite the fact that said liquor licensees are for-profit business entities, for the sole purpose of selling alcoholic beverages for consumption in a designated and secured area adjacent to each of said licensed premises, to be approved by the Village pursuant to the issuance of a temporary event permit under Chapter 110 of the Village Code, beginning two (2) hours prior to the start of one (1) Blackhawks Western Conference Chicago Semi-Finals. Conference Finals, or Stanley Cup Finals, between May 9, 2015 and June 7, 2015, should the Chicago Blackhawks play on the above dates, and terminating thirty (30) minutes after the conclusion of said games. The liquor licenses to be issued under this subsection (7) may be issued by the Local Liquor Commissioner upon proper application to the Village, and satisfaction of all applicable requirements and conditions by the licensees. No liquor license shall be issued under this subsection (7) until such time as each licensee obtains the necessary temporary event permit under Chapter 110 of the Village Code and complies with all requirements and conditions thereof, including, without limitation, the insurance, bond and indemnification requirements of Chapter 110 for temporary event."

SECTION 2: That, effective at 11:59 p.m. on Sunday June 7, 2015, Title 11, Chapter 112, Section 112.18(B)(7) of the Lombard Village Code, as set forth in Section 1 above, is hereby repealed, without need for any further action by the President and Board of Trustees. SECTION 3: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law. Passed on first reading this _____ day of ______, 2015. AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.47(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO TEMPORARY EVENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 110, Section 110.47(B) of the Lombard Village Code is amended by adding the following language to the end thereof:

"In the case of an entity which holds a Class "J" liquor license, pursuant to Section 112.18(B)(6) of this Code, a single permit shall be issued covering the Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup Finals, relative to the events held in conjunction with said Class "J" liquor license during said Western Conference Semi-Finals, Western Conference Finals, or Stanley Cup Finals."
