Subject: FY 2011 Bituminous Mix Purchase

The County of DuPage, Illinois has awarded contract #10-027 for Bituminous Mix for the FY 2011. The successful bidder is DuKane Asphalt Company. Public Works contacted Jeffrey Dunteman requesting approval to purchase asphalt through DuKane Asphalt Co. from June 1, 2010 through May 31, 2011 under the terms, conditions and pricing awarded to the County of DuPage, Illinois contract. On May 25, 2010 I received confirmation allowing the Village to purchase asphalt through DuKane Asphalt Co.

Public Works is requesting a waiver of bids and award of a contract to DuKane Asphalt Co. not to exceed \$211,650.00 to purchase Bituminous Mix on an as-needed basis in accordance with the County of DuPage, Illinois Joint Purchasing Contract as allowed by the Finance Department Purchasing Manual.
