SUBJECT: **Text Amendment to Title 11, Chapter 121, Section 121.03A.(2)**
Number of Public Passenger Licenses

Village Code Title 11, Chapter 121, Section 121.03 states that all taxicab operators providing services within the Village shall be required to secure a business license prior to commencing such services.

FREETAXI.BIZ Dispatch, Inc. currently holds Taxicab License Number 16 which allowed them to operate within the Village of Lombard through June 30, 2015. Since that time, FREETAXI.BIZ Dispatch Inc. has not paid the \$250 renewal fee for the July 1, 2015 through June 30, 2016 licensing period. Staff contacted one of the owners and was informed that they would not be renewing their license for financial reasons.

Attached is an ordinance amending Title 11, Chapter 121, Section 121.03A.(2) decreasing the number of Public Passenger Licenses from fourteen to thirteen to reflect the non-renewal of the aforementioned license.

Staff is requesting a waiver of first reading in order to reflect the correct number of public passenger licenses.

ORDINANCE _____

AN ORDINANCE AMENDING TITLE 11, CHAPTER 121,
SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be thirteen (13) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the non-renewal of the license by FREETAXI.BIZ Dispatch, Inc. located at 1013 Eastern Avenue, Bellwood, Illinois.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
