Re: Gun Trade In for Rifle Barrels

Our range officers have identified 12 old shotguns and one 9 mm rifle we no longer use and they wish to dispose of them to make room in our arsenal. They have also identified the need to replace the barrels on 10 used military surplus M-16 rifles we own due to excessive wear. We received these military rifles without cost and these upper barrel assemblies will greatly extend their useful life and are routine maintenance items.

This proposed purchase contains a trade in allowance for the 13 guns toward the purchase of 10 AR-15 uppers from G.A.T. Guns, Inc. located in Dundee, Illinois. Our range officers attempted to get additional quotes from other gun dealers but none responded to our requests.

The costs for the proposed purchase and trade in are as follows:

Ten (10) AR-15 Uppers	\$5,490.00
Trade in allowance for 13 guns	-\$1,900.00
Total Purchase	\$3,590.00

The expense for the repair parts is budgeted in cost center 2120.756360.
