Elizabeth St. Parking Restriction

Elizabeth Street has a horizontal curve at Hickory Rd. with a standard roadway width. Sight lines are restricted from Elizabeth Ct. through Willow St. Due to the restricted sightlines and curve intersection, parking restrictions on the hydrant (western) side were considered for this location. Staff recommended providing a west side parking restriction from Elizabeth Ct. to Willow St. based on the previous information.

During the May 11, 2015 meeting, the Transportation and Safety Committee voted to recommend adding the parking restriction in accordance with staff recommendation.

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) is amended to at the following restriction:

"Elizabeth Ct. to Willow St." at "Elizabeth St., west side"

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
