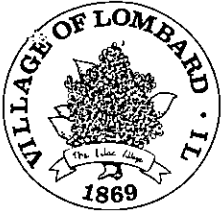

SUBJECT: Two Amendments to Chapter 110, Section 110.21(C) of the Lombard Village Code in Regard to the Number of Coin Operated Amusement Device licenses.

As provided for by the ordinance governing the licensing of coin operated amusement devices, attached are two ordinances, one that amends the number of approved Class A licenses and one that amends the number of Class B licenses.

The ordinance amending the number of Class A licenses reflects the termination of the license to Sadco Inc. d/b/a Sal's Pizza and the issuance of a license to Sadco One Inc. who is now operating the business known as Sal's Pizza located at 410 W. 22<sup>nd</sup> Street, Lombard.

The ordinance amending the number of Class B licenses reflects the termination of the license to Knuckleheads Inc. d/b/a E.J. Rileys and the issuance of a license to J. Knuckleheads Inc. who is now operating the business known as E.J. Rileys located at 201 E. Roosevelt Road, Lombard.

We request that this item be placed on the Consent Agenda of the July 21, 2005 meeting of the Board of Trustees. Waiver of first reading is requested.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.21(C)  
OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 11, Chapter 110, Section 110.21(C), of the Lombard Village Code is amended by revising the entry relative to the Class "B" coin operated amusement device license, contained therein, to read as follows:

Class "B" - 1

This decrease in Class "B" coin operated amusement device licenses reflects the termination of Knuckleheads Inc. d/b/a E. J. Rileys and the termination of the Class "B" coin operated amusement device license issued Knuckleheads Inc. in relation thereto.

Section 2: That Title 11, Chapter 110, Section 110.21(C), of the Lombard Village Code is amended by revising the entry relative to the Class "B" coin operated amusement device license, contained therein, to read as follows:

Class "B" - 2

This increase in Class "B" coin operated amusement device licenses reflects the issuance of a Class "B" coin operated amusement device license to J Knuckleheads Inc. who is operating the business commonly known as E. J. Rileys located at 201 E. Roosevelt Road, Lombard..

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
