100546; Ordinance to Modify Existing Parking Restrictions On Certain Streets Near Westmore School

On October 4, 2010, the Transportation and Safety Committee discussed housekeeping issues to the Village Traffic Code concerning time limit parking conflicts on certain streets around Westmore School. Specifically, recently adopted parking time limit restrictions (May, 2010) on streets surrounding the Westmore School are inconsistent with pre-existing parking time limits located across the street. The Committee voted to modify the Traffic Code concerning parking restrictions on certain streets around Westmore School, requiring various modifications to the Traffic Code. This action requires an ordinance to the Traffic Code as follows:

ORDINANCE NO.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:
