Contract

The current Capital Improvement Plan (CIP) has programmed IL Route 53 at Madison Street for construction in FY 2016 in conjunction with the Illinois Department of Transportation (IDOT) and York Township. This project will use outside funding sources (federal Surface Transportation Program and IDOT state contribution) along with Village funds, and completed construction documents will be submitted to IDOT in mid-October. The project will consist of intersection widening, road resurfacing and reconstruction, a traffic signal installation, and storm sewer improvements.

A Request For Proposal (RFP) was sent to all eligible firms on the 2015 Resident Engineering Shortlist. Thomas Engineering Group, LLC was determined to be the most qualified firm and was the resident engineer for the Great Western Trails and Surges Center projects. The project scope and fee was directly negotiated with Thomas Engineering Group and agreed to by both parties.

The scope of work for this contract is construction inspection, documentation, and materials testing. This includes construction observation, staking, documentation, drawing review, laboratory testing, and meeting participation.

This work will be performed for a total engineering fee not to exceed \$279,998. The engineering costs will be paid through the Motor Fuel Tax Fund, and the Village anticipates partial reimbursement from IDOT for this cost. The current CIP budgets \$395,400 in FY 2016 for Resident Engineering and Construction Material Testing and is thereby under budget.

Please present this agreement and resolution for Resident Engineering services to the President and Board of Trustees for their review at their regular meeting of October 1, 2015. If approved, please return two original signed copies of the agreement to Public Works—Engineering for further processing.
