ORDINANCE _______ AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN _______REGARD TO ALCOHOLIC BEVERAGES______

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor license, contained therein, to read as follows:

Class "A/B-I" - 4

This decrease in Class "A/B-I" liquor licenses reflects the sale of the assets of Enbu Inc. d/b/a Momotaro Japanese Restaurant and the termination of the Class "A/B-I" liquor license issued to Enbu Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor license, contained therein, to read as follows:

Class "A/B-I" - 5

This increase in Class "A/B-I" liquor licenses reflects the issuance of a Class "A/B-I" liquor license to Momotaro Inc.who will be operating the business commonly known as Momotaro Japanese Restaurant located at 801 E. Butterfield Road, Lombard.
