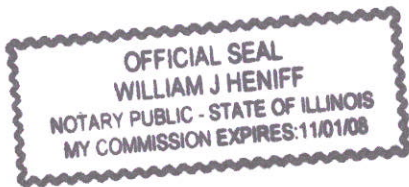

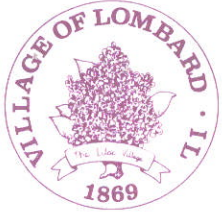

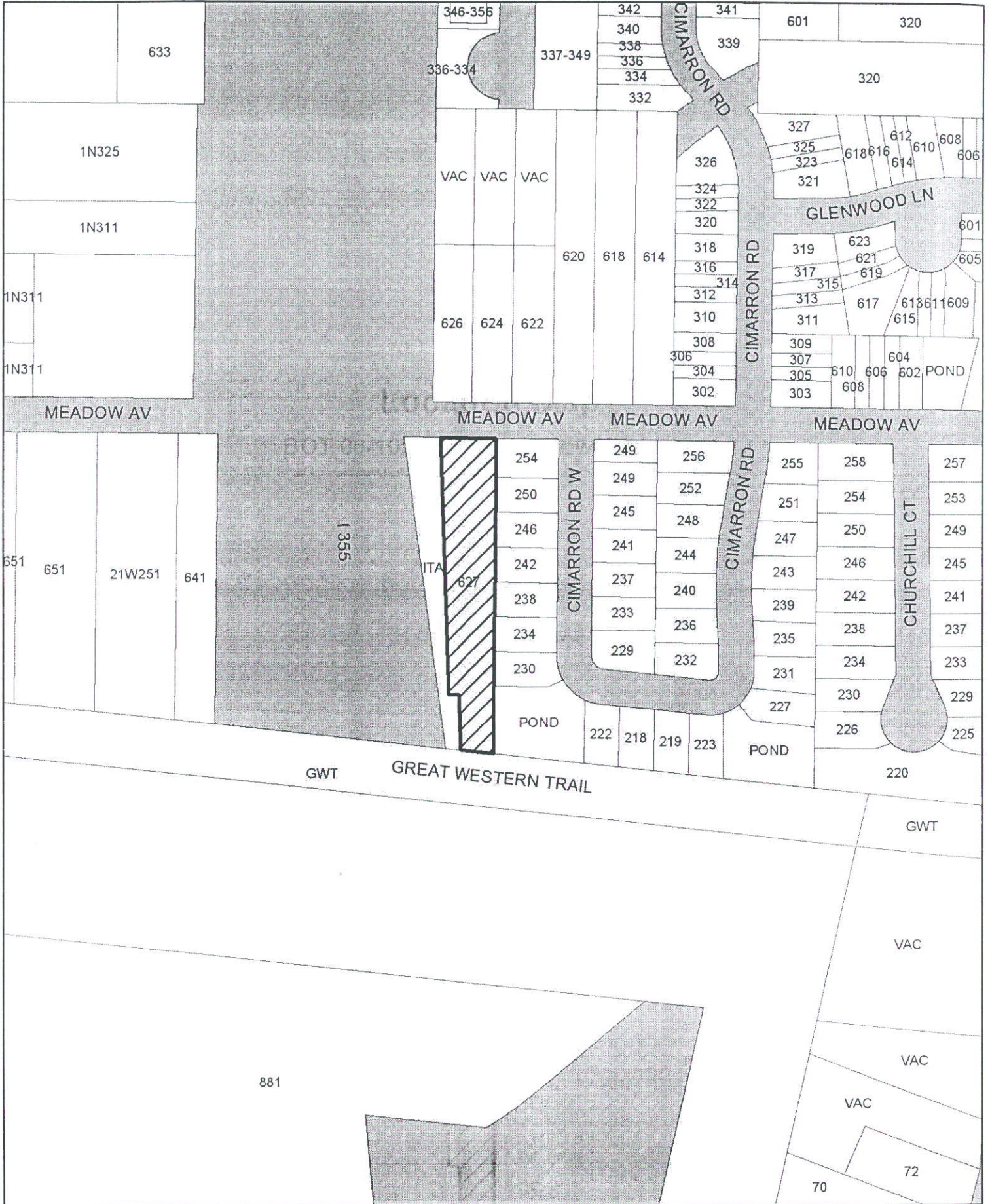

BOT 06-10: 627 W. Meadow Avenue

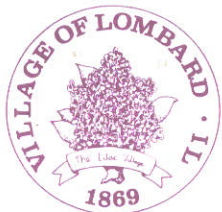

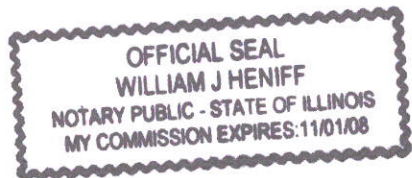

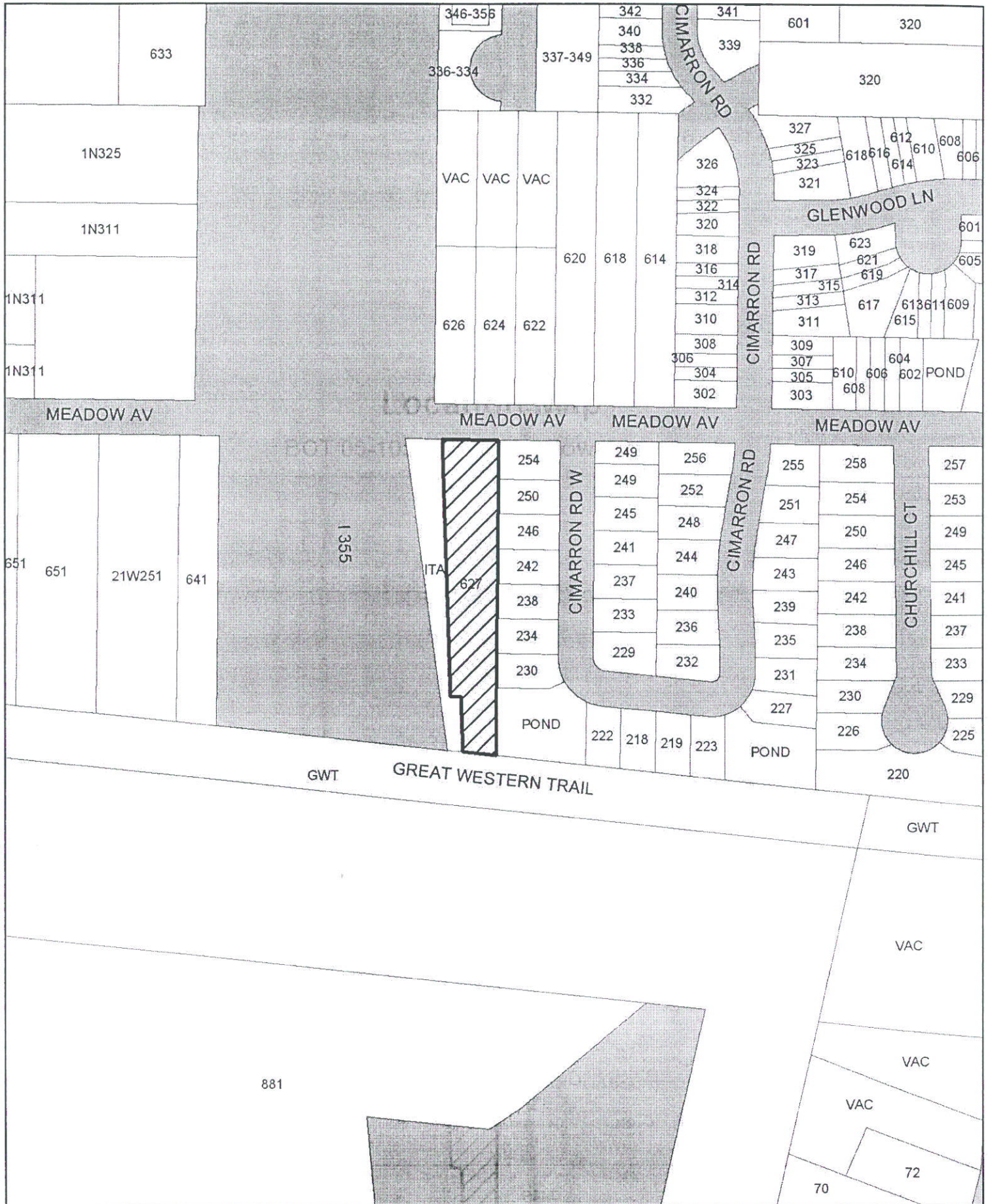
