**SUBJECT: Request for a Class “M-VG” Liquor License – Enchanted Castle
1103 S. Main St.**

As you are aware the Village of Lombard Board of Trustees on April 4, 2019 approved video gaming for certain liquor license classifications by Ordinance 7647.

FPS LLC d/b/a Enchanted Castle located at 1103 S. Main St. currently holds a Class “M” liquor license which allows the sale of beer and wine with the primary purpose of the establishment being a restaurant with more than eight coin-operated amusement devices.

Staff is currently in the process of renewing liquor licenses for the July 1 through December 31, 2019 liquor licensing term. FPS LLC d/b/a Enchanted Castle has decided to voluntarily not renew their Class “M” license for the upcoming liquor licensing term and FPS LLC d/b/a Enchanted Castle applied for a new Class “M-VG” liquor license.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the number of entries in the Class “M” liquor license category by one and increasing the number of entries in the Class “M-VG” license category by one, effective July 1, 2019.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "M" liquor license, contained therein, to read as follows:

Class "M" - 0

This decrease in the number of Class "M" liquor licenses reflects the voluntary non-renewal of FPS LLC located at 1103 S. Main St. for the July 1 through December 31, 2019 licensing term and the termination of the Class "M" liquor license issued to FPS LLC in relation thereto.

Section 2: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "M-VG" liquor license, contained therein, to read as follows:

Class "M-VG" - 1

This increase in the number of Class "M-VG" liquor licenses reflects the issuance of a new Class "M-VG" liquor license to FPS LLC d/b/a Enchanted Castle located at 1103 S. Main St., Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
