AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein to read as follows:

Class "C" - 4

This decrease in Class "C" liquor licenses reflects the change in ownership of Patio Restaurant of Lombard Inc. d/b/a Patio Restaurants located at 2780 S. Highland Ave., Lombard and the termination of the Class "C" liquor license issued to said licensee in relation thereto.

SECTION 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein to read as follows:

Class "C" - 5

This increase in Class "C" liquor licenses reflects the issuance of Class "C" liquor license to Patio Restaurant of Lombard Inc. d/b/a Patio Restaurant located at 2780 S. Highland Ave., Lombard reflecting ownership change to include a breakdown of 50%-25%-25% ownership.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
