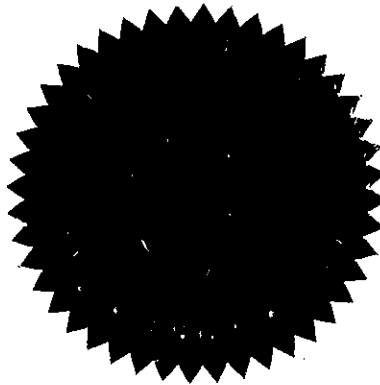



**AN ORDINANCE AMENDING TITLE 3, CHAPTER 33 OF
THE LOMBARD VILLAGE CODE IN REGARD TO THE FEE
CHARGED TO CPR INSTRUCTORS WHO WISH TO AFFILIATE
WITH THE FIRE DEPARTMENT IN ITS CAPACITY
AS A CPR COMMUNITY TRAINING CENTER**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 3, Chapter 33 of the Lombard Village Code is amended by adding a new Section 33.48 thereto which shall read in its entirety as follows:

**§33.48 CARDIO PULMONARY RESCUSITATION (CPR) INSTRUCTOR
AFFILIATION FEE**

(A) Any Lombard area CPR instructor may affiliate with the Village's Fire Department in its capacity as a CPR Community Training Center, for the purpose of obtaining support services, upon payment of an annual fee of twenty-five and no/100 dollars (\$25.00).

(B) The annual fee set forth in subsection (A) above shall not be applicable to any Village employee who is a CPR instructor teaching CPR classes in his/her capacity as a Village employee."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
