Village Manager William T. Lichter Dear Mr. Tucker:

This is to acknowledge receipt of your correspondence dated September 21, 2005 in which you indicate that the National Park Service has reversed its decision to cancel the Save America's Treasures Grant in the amount of \$296,303 for the DuPage Theatre restoration project in the Village of Lombard. In your letter you refer to the DuPage Theatre Foundation as the grantee, and indicate that only the grantee can cancel or refuse the grant. However, given that the Village of Lombard was the grant applicant and continues to be the property owner, Grant Agreement No. 17-04-ML-0019 signed by Mr. Martin Carroll on behalf of the DuPage Theatre Foundation was mistakenly accepted as valid by the National Park Service.

In that regard, I offer the following information:

"The *Mission* of the Village of Lombard is to provide superior and responsive governmental services to the people of Lombard."

- a. The application for the Save America's Treasures grant was filed by the Village of Lombard and signed by Lombard Village Manager William T. Lichter as Authorizing Official on May 15, 2003.
- b. The Project Information Form lists the Village of Lombard as the Sponsor Organization, identifies the Village of Lombard as the property owner of the DuPage Theatre and Shoppes, and indicates that the Village of Lombard will supply the matching funds for the project. The Project Information Form was signed by Leonard Flood, Lombard Director of Finance/Treasurer, as authorized representative of the project sponsor and property owner on December 17, 2003.
- c. Ms. Cynthia Ward, Administrative Director of the DuPage Theatre Foundation, was noted on the Project Information Form only as the project contact. Ms. Ward is not an employee of the Village of Lombard. At no

time during the grant process was she identified as an authorized representative of the grant applicant and property owner – the Village of Lombard.

- d. The National Park Service and DuPage Theatre Foundation entered into Grant Agreement No. 17-04-ML-0019 on March 4, 2004 without approval of the corporate authorities of the Village of Lombard. At no time did the corporate authorities of the Village of Lombard authorize Mr. Martin Carroll to sign the grant agreement.
- e. Based on decisions to date made by the Lombard Board of Trustees, it is clear that the Village will not grant the easements required pursuant to the grant regulations. Accordingly, the DuPage Theatre Foundation will be unable to fulfill the provisions of the grant as specified in the Grant Agreement.
- f. The DuPage Theatre Foundation has no fee title, leasehold, or other interest in the property and has had no interest since April 2005 when the Foundation voluntarily terminated its Agreement with the Village of Lombard rather than have the Board of Trustees take action on a Notice of Termination (correspondence attached).


It is the position of the Village of Lombard, as grant applicant and property owner, that the Village is the only legally established local agency authorized to enter into a grant agreement regarding the Save America's Treasures Grant for the DuPage Theatre and Shoppes. Accordingly, this is to reaffirm the formal rejection by the Lombard Board of Trustees of the Save America's Treasures Grant as indicated in my letter of September 2, 2005.

Dear Mr. Carroll:

As you know, on January 3, 2005, the Village of Lombard served a Notice of Default on the DuPage Theatre Foundation pursuant to Section VII of the above-captioned Agreement. As of the end of the sixty (60) day cure period (March 4, 2005) the identified default had not been cured. At the April 7, 2005 Lombard Village Board meeting, the DuPage Theatre Foundation made a presentation relative to an alternate redevelopment proposal in regard to the DuPage Theatre and Shoppes. At that time, you represented to the Village Board that, rather than having the Village Board take action on a Notice of Termination relative to the above-captioned Agreement, the DuPage Theatre Foundation would voluntarily terminate the above-captioned Agreement, pursuant to a written correspondence to be forwarded to the Village. Based upon said representation, the Village Board took no action in regard to a Notice of Termination relative to the above-captioned Agreement. The Village Board did, however, authorize the Village staff to agree to the voluntary termination of the above-captioned Agreement in the event that a written voluntary termination notice was received from the DuPage Theatre Foundation.

by its government working Based on the foregoing, this letter will confirm the receipt by the Village of the written notice, dated April 11, 2005 and executed by you on behalf of the DuPage Theatre Foundation, pursuant to which the DuPage Theatre Foundation has indicated to the Village its desire to and an outstanding quality voluntarily terminate the above-captioned Agreement. In light of the foregoing and the action taken by the Village Board on April 7, 2005, please be advised that the Village hereby consents to the voluntary termination of the above-captioned Agreement, with said Agreement to be deemed null and void as of the date hereof.

> With the voluntary termination of the above-captioned Agreement, I would request that the DuPage Theatre Foundation take the following action:

- 1. Return all keys relative to the DuPage Theatre and Shoppes to the Village Manager;
- 2. Provide a final accounting, relative to the expenditure of all funds provided to the DuPage Theatre Foundation by the Village, to the Village's Finance Director, and

3. Advise all vendors and consultants, that the DuPage Theatre Foundation has been working with, of the voluntary termination of the above-captioned Agreement.

Finally, in regard to the DuPage Theatre Foundation's request to enter into a new redevelopment agreement, based upon the presentation made at the April 7, 2005 Village Board meeting, please be advised that said request is noted, and will be addressed at a future date by the Village Board. At such time as said future date is determined, you will be advised of the date by Village staff.
