AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "A/B-III-VG" LIQUOR LICENSES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "A/B-III-VG" liquor license category, to read in its entirety as follows:

"A/B-III-VG" - 2"

This increase in the number of Class "A/B-III-VG" liquor licenses reflects the issuance of a new Class "A/B-III-VG" liquor license to YTEG Lombard Inc. d/b/a Roadhouse 38, located at 275 W. Roosevelt Road, Lombard, Illinois.
