

ORDINANCE 4840 AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein, to read as follows:

Class "F" - 3

This decrease in Class "F" liquor licenses reflects the sale of the assets of J.D. Ventures, Inc. and the termination of the Class "F" liquor license issued to J.D. Ventures, Inc./S & R Drugs in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein, to read as follows:

Class "F" - 4

This increase in Class "F" liquor licenses reflects the issuance of a Class "F" liquor license to Pioneer Hills, Limited, LLC who will be operating the business commonly known as S & R Drugs, 338 S. Main Street, Lombard subject to the condition set forth in Section 3 below.

Section 3: In the event that Pioneer Hills, Limited, LLC does not provide the Village with a copy of its fully executed Lease Agreement for the premises known as S & R Drugs, 338 S. Main Street, Lombard on or before August 15, 2000, Section 2 of this Ordinance shall become null and void.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
