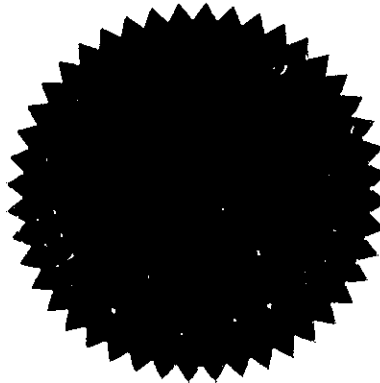

**ORDINANCE NO. 4728**

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Eisenhower Lane North North side	1285 feet East of the North Curb Line of Eisenhower Lane	a point 1360 feet East
Eisenhower Lane North South side	1285 feet East of the North curb line of Eisenhower Lane	a point 1345 feet East
Ridge Avenue East side	1240 feet North of the North curb line of Frontage Road	a point 190 feet North

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Ridge Avenue East side	1240 feet of the North curb line of Frontage Road	a point 90 feet north

Section 3: That Schedule VIII (r) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS between the hours of 4:00 p.m. and 8:00 p.m. Monday through Friday be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Michelle Lane East side	Dead End	a point 265 feet North

Ordinance Amending the Lombard Traffic Code

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.


