SUBJECT: **Text Amendment to Title 11, Chapter 121, Section 121.03A.(2)
Number of Public Passenger Licenses**

Village Code Title 11, Chapter 121, Section 121.03 states that all taxicab operators providing services within the Village shall be required to secure a business license prior to commencing such services.

Oak Brook Taxi & Limo Company located at 16548 Lane Drive, Lockport IL, MPT - My Personal Taxi & Livery located at 1 Lincoln Center, #1500, Oakbrook Terrace IL, The One Taxi, Inc., located at 627 N. York Street, Unit 1101, Elmhurst IL, Center Ice Taxi located at 336 N. Illinois Ave., #D, Villa Park, IL and Metro Yellow Cab located at 5105 Pearl St., Schiller Park IL had current taxicab licenses to operate within the Village of Lombard through June 30, 2017. Since that time, none have paid the \$250 renewal fee for the July 1, 2017 through June 30, 2018 licensing term. Staff contacted each taxicab operator and they all confirmed that they will not be renewing their taxicab licenses for the 2017-2018 licensing term.

Attached is an ordinance amending Title 11, Chapter 112, Section 121.03A.(2) decreasing the number of Public Passenger Licenses from eleven (11) to six (6) to accommodate the non-renewal of the aforementioned licensees.

Staff is requesting a waiver of first reading in order to reflect the current number of public passenger licenses.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 121,
SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:**

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be six (6) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the non-renewal of the license by:

- Oak Brook Taxi & Limo Company, 16548 Lane Drive, Lockport IL
- MPT - My Personal Taxi & Livery, 1 Lincoln Center, #1500, Oakbrook Terrace IL
- The One Taxi, Inc., 627 N. York Street, Unit 1101, Elmhurst IL
- Center Ice Taxi, 336 N. Illinois Ave., #D, Villa Park, IL
- Metro Yellow LLC d/b/a Metro Yellow Cab, 5105 Pearl St., Schiller Park IL

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
