AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.21(C) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF AUTHORIZED COIN-OPERATED AMUSEMENT DEVICE LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

<u>Section 1</u>: That Title 11, Chapter 110, Section 110.21(C), of the Lombard Village Code is amended by revising the entry relative to the Class "A" coin operated amusement device license, contained therein, to read as follows:

Class "A" - 5

This decrease in Class "A" coin operated amusement device licenses reflects the termination of the license issued to O'Neill's Pub Inc. d/b/a O'Neill's Pub located at 236 E. St. Charles Road, Lombard.

Section 2: That Title 11, Chapter 110, Section 110.21(C), of the Lombard Village Code is amended by revising the entry relative to the Class "A" coin operated amusement device license, contained therein, to read as follows:

Class "A" - 6

This increase in Class "A" coin operated amusement device licenses reflects the issuance of a Class "A" coin operated amusement device license to NVRBTR Corporation, d/b/a O'Neill's Pub located at 236 E. St. Charles Road, Lombard..

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
