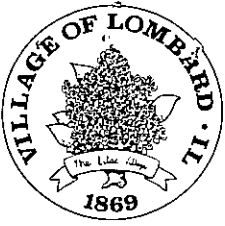

**Subject:** Recommendations from the Transportation and Safety Committee

---

At the September 13, 2004, Transportation and Safety Committee meeting, the committee recommended the following items:

- Not to establish a traffic calming policy at this time.
- Change the existing “No Turn on Red, 8 AM – 4 PM” signs on all approaches at Westmore-Meyers Road and Madison Street to “No Turn on Red, 8 AM – 4 PM, Monday-Friday”.
- Shorten the bus zone on the north side of Parkside Avenue, west of Main Street, from 155-feet to 50-feet and install “No Parking, Standing, Stopping, Bus Zone” signs.

The following sections of the traffic code require an ordinance modification:

**Delete:** Schedule XIII – Right Turns on Red Traffic Signals

- a) All four corners: Westmore Avenue and Madison Street (8:00 A.M. to 4:00 P.M.)

**Add:** Schedule XIII – Right Turns on Red Traffic Signals

- a) All four corners: Westmore-Meyers Avenue and Madison Street (8:00 A.M. to 4:00 P.M., Monday through Friday)

**Delete:** Schedule XI – Section 10-13-11 - Cab Stands, Bus zones & Village Vehicle Zones

Parkside Avenue, north side from 75 feet east of the east curb line of Park Avenue to 220 feet east of the east curb line of Park Avenue.

**Add:** Schedule XX – No Stopping, Standing or Parking

Parkside Avenue, north side from 220 feet west of the west curb line of Main Street to a point 50 feet west.

**Delete:** Schedule VII – Section 10-13-6 – Parking Prohibited at all Times on Certain Streets

Parkside Avenue, north side from the west curb line of Grace Street to 50 feet west of the west curb line of Main Street.

**Add:** Schedule VII – Section 10-13-6 – Parking Prohibited at all Times on Certain Streets

Parkside Avenue, north side from the west curb line of Grace Street to 220 feet west of the west curb line of Main Street.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XIII of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to delete the following therefrom:

All four corners: Westmore-Meyers Avenue and Madison Street (8:00 a.m. to 4:00 p.m.)

Section 2: That Schedule XIII of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to add the following thereto:

All four corners: Westmore-Meyers Avenue and Madison Street (8:00 a.m. to 4:00 p.m., Monday through Friday)

Section 3: That Schedule XI of the Lombard Traffic Code (Ordinance 1186) entitled CAB STANDS, BUS ZONES & VILLAGE VEHICLE ZONES be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Parkside Avenue, North side	75 feet east of the east curb line of Park Avenue	220 feet east of the east curb line of Park Avenue

Section 4: That Schedule XX of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Parkside Avenue North side	220 feet west of the west curb line of Main Street	a point 50 feet west

Section 5: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Parkside Avenue North side	west curb line of Grace Street	50 feet west of the west curb line of Main Street

Section 6: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Parkside Avenue North side	west curb line of Grace Street	220 feet west of the west curb line of Main Street

Section 7: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
