Subject:

Construction Zone Speed Limits

Staff requests the Committee recommend the attached ordinance, prepared by the Village Attorney, for approval by the Board of Trustees. This ordinance provides the Village with updated language relating to persons speeding or parking within designated construction zones. For reference, the existing portions of the traffic code that will be ammended are attached. This language update brings the Village's Traffic Code in line with the State of Illinois' Traffic Code as it allows for both an increased fine for speeding in a designated construction and an increased fine for offenders with multiple speeding violations in a construction zone.

Staff recommends approval of the ordinance as written.

AN ORDINANCE AMENDING ARTICLES VI AND XIX OF THE LOMBARD TRAFFIC CODE (ORDINANCE NO. 1186) IN RELATION TO CONSTRUCTION ZONE VIOLATION FINES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Article VI, Section 10-6-5G of the Lombard Traffic Code is amended to read in its entirety as follows:

"G. Any person found to be in violation of Subsection B above shall be fined not less than one hundred fifty and no/100 dollars (\$150.00) nor more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees."

SECTION 2: That Article VI, Section 10-6-5 of the Lombard Traffic Code is amended by adding a new Subsection H thereto, which shall read in its entirety as follows:

"H. Any person found to be in violation of Subsection A above shall be fined not less than two hundred fifty and no/100 dollars (\$250.00) nor more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees, for a first violation. Any person found to be in violation of Subsection A above a second or further time shall be fined not less than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees."

SECTION 3: That Article XIX, Section 10-19-2 of the Lombard Traffic Code is hereby amended by adding the following language to the beginning thereof:

"Except as provided in Section 10-6-5 of this Traffic Code,"

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
