SUBJECT: First Amendment to Memorandum of Understanding with the Helen Plum

Library Relative to The Elmhurst Hospital Parking Lot

In July 2023 the Village and the Helen Plum Library entered into a Memorandum of Understanding for the use of 44 spaces controlled by the HPL in the Elmhurst Memorial Hospital (EMH) Lot. The MOU provided that the Village would obtain access to these spaces through December 31, 2023. It was anticipated that prior to December 31, 2023, the HPL property would be conveyed to the Lombard Park District and that the Village would enter into an agreement with the Lombard Park District for the use of the spaces.

Due to the timing of the conveyance of the property, the HPL will own the library property, as well as the 44 spaces at the EMH lot beyond December 312, 2023. In order to allow the Village to have access to the 44 spaces for commuter purposes beyond December 31, 2023, the parties have agreed to extend the MOU until such time as the property is conveyed to the Lombard Park District or July 1, 2024. The attached First Amendment to the MOU has been prepared by the Village Attorney and presented to the HPL Board. It is expected that the library will take action to approve the First Amendment at their November 21, 2023 meeting.

Recommendation:

Staff recommends that the Village Board approve a Resolution authorizing the Village President and Village Clerk to enter into a First Amendment to the Memorandum of Understanding with the Helen Plum Library for a portion of the Elmhurst Memorial Hospital Lot.
