**SUBJECT:** Plan Commission Appointments

As you are aware, the Lombard Plan Commission has one pending vacancy on the Plan Commission due to the Chairperson Donald Ryan resigning as both the Chairperson as well as a Plan Commission member after 28 years of service.

President Giagnorio, Donald Ryan and Village staff met to discuss both the Chairperson vacancy as well as the opening on the Commission. Though this discussion and in follow-up conversations, Ronald Olbrysh is being recommended to replace Donald Ryan as Chairperson of the Plan Commission. Commissioner Olbrysh has been a valued member of the Plan Commission for many years and has been a valued member.

To fill the pending vacancy of the Plan Commission itself, former Village Trustee Bill Johnston is being recommended for consideration. Both of these appointments will require approval by the Village Board.

In addition, the terms of Commissioner Flint and Commissioner Sweetser expired in 2019. Both have stated they would like their terms to be extended four additional years to 2023.

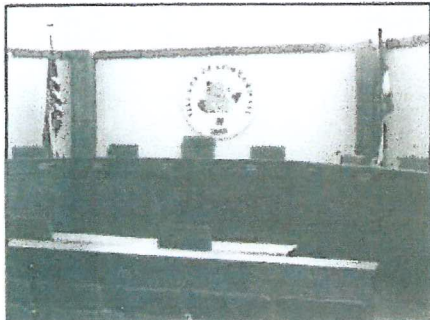
