

specified in this section or as indicated on official signs, except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control device.

- (b) Regulations not exclusive. The provisions of this section imposing a time limit on parking shall not relieve any person from the duty to observe other and more restrictive provisions prohibiting or limiting the stopping, standing or parking of vehicles in specified places or at specified times.
- (c) Parking prohibited at all times. When signs are erected giving notice thereof, no person shall park a vehicle at any time upon any of the streets or portions thereof described in motor vehicle and traffic schedule VI.
- (d) Parking prohibited during certain hours. When signs are erected giving notice thereof, no person shall park a vehicle between the hours specified in motor vehicle and traffic schedule VII on any day except Sundays and legal holidays upon any of the streets or portions thereof described in such schedule.
- (e) On-street parking time limited. When signs are erected giving notice thereof, no person shall park a vehicle for longer than the time designated in motor vehicle and traffic schedule VIII on any day except Sundays and legal holidays upon any



except Sunday and legal holidays on any of the

streets described in such schedule. For the purpose of this subsection, a separate offense occurs at the expiration of each maximum parking time limit.

- (h) Holiday and Sunday exception. Parking time finit regulations and parking meter regulations as set forth in this chapter shall not be enforced on Sundays or legal holidays. For purposes of this chapter, legal holidays are as follows: January 1; Presidents' Day; Memorial Day; July 4; Labor Day; Thanksgiving Day; and December 25.
- (i) Central business district municipal parking lots I and 2. No person shall park a vehicle in any space within central business district parking lots no. 1 (Municipal Parking Structure, south side of Wesley between Hale Street and Wheaton Avenue) and no. 2 (south side of Wesley between Mair. Street and Hale Street) for more than the time limits as posted between the hours of 8:00 a.m. and 6:00 p.m., nor shall they move from space to space within the designated lot in order to extend the parking time limits for their use, Monday through Saturday, holidays excepted. (Code 1968, § 16-217; Ord. No. F-0499, § 1, 8-7-00)

Editor's note—The schedules referred to in the preceding section; schedule VI, parking prohibited at all times on certain streets; schedule VII, parking prohibited during certain hours on certain streets; schedule VIII, parking time (nonmetered) limited on certain streets and off-street lots, are not printed in this Code, but are on file in the city offices.

## Sec. 70-355. Standing, parking in fire lane.

No person shall stand or park a motor vehicle within an area designated as a fire lane. Such violation shall be subject to the penalties provided in this chapter.

(Code 1968, § 16-220)

### Sec. 70-358. Customer designated parking.

(a) No person who owns, operates, manages, or is employed at a place of business in the zone bounded by Seminary, Scott, Illinois, and West Streets (central business district) shall park in spaces designated as customer parking only, while the person is working at the business.
