#### **ORDINANCE NO. 7088**

# AN ORDINANCE AMENDING TITLE 3, CHAPTER 31 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE DESIGNATION OF A PRESIDENT PRO TEM AND A TEMPORARY CHAIRMAN

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 3, Chapter 31 of the Lombard Village Code is amended by adding a new Section 31.15 thereto, which shall read in its entirety as follows:

### "§31.15 DESIGNATION OF PRESIDENT PRO TEM AND TEMPORARY CHAIRMAN

The Senior Trustee, based upon the length of time of continuous uninterrupted service on the Village Board, shall serve as President Pro Tem and Temporary Chairman, as set forth in Section 31.16 and Section 31.17 of this Code. In the event that more than one Trustee has the same length of time of continuous uninterrupted service on the Village Board, such that more than one Trustee would qualify as the Senior Trustee, it shall first be determined if more than one of said Trustees desires to serve as President Pro Tem and Temporary Chairman. If only one of said Trustees desires to serve as President Pro Tem and Temporary Chairman, then said Trustee shall so serve. If more than one of said Trustees desires to serve as President Pro Tem and Temporary Chairman, then the President Pro Tem and Temporary Chairman shall be chosen by a lottery to take place at the next available Village Board meeting. In regard to said lottery, the names of all Trustees qualifying to serve, and who desire to serve, as President Pro Tem and Temporary Chairman, shall be written on separate pieces of paper, which shall be placed in a container, and the Village Clerk shall, without looking at the pieces of paper on which each name has been written, choose a piece of paper on which a name has been written. The Trustee whose name appears on said selected piece of paper shall thereafter serve as the President Pro Tem and Temporary Chairman until said Trustee no longer serves as a Trustee."

**SECTION 2:** That Title 3, Chapter 31 of the Lombard Village Code is amended by adding a new Section 31.16 thereto, which shall read in its entirety as follows:

### "§31.16 PRESIDENT PRO TEM

If a temporary absence or disability of the Village President incapacitates him/her from the performance of his/her duties, but does not create a vacancy in the office, the Village Board has hereby determined that the Trustee selected pursuant to Section 31.15 of this Code, shall act as President Pro Tem. The President Pro Tem, during the absence or disability, shall perform the duties and possess all the rights and powers of the Village President, but shall not be entitled to vote both as President Pro Tem and as Trustee."

**SECTION 3:** That Title 3, Chapter 31 of the Lombard Village Code is amended by adding a new Section 31.17 thereto, which shall read in its entirety as follows:

### **"§31.17 TEMPORARY CHAIRMAN**

If the Village President or Acting Village President is absent from a meeting, and the absence is not the result of a vacancy in office nor of such a nature as to require a President Pro Tem under Section 31.16 of this Code, the Village Board has hereby determined that the Trustee selected pursuant to Section 31.15 of this Code, shall act as Temporary Chairman for purposes of chairing said meeting. The Temporary Chairman shall have only the powers of a presiding officer and shall retain the right to vote in his/her capacity as Trustee on any Ordinance, Resolution or Motion."

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
