AN ORDINANCE AMENDING ORDINANCE NO. 4482, ADOPTED JUNE 4, 1998, AND AMENDED BY ORDINANCE NO. 4715, ADOPTED SEPTEMBER 16, 1999, RELATIVE TO THE VACATION OF A PORTION OF THE EDSON STREET RIGHT-OF-WAY NORTH OF ROOSEVELT ROAD, LOMBARD, IL

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted Ordinance No. 4482, approving the vacation of the Edson Street right-of-way north of Roosevelt Road.; and,

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted Ordinance No. 4715, approving an extension of time to provide for the construction of all improvements as outlined in SECTION 4, paragraph H., until September 1, 2000; and

WHEREAS, the petitioner has requested an additional extension of time to provide for the construction of all improvements as outlined in SECTION 4, paragraph H., and,

WHEREAS, the President and Board of Trustees have determined that it is in the best interest of the Village of Lombard to grant said extension of time;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That SECTION 4, paragraph H, of Ordinance No. 4482, adopted June 4, 1998, and amended as part of Ordinance 4715, adopted September 16, 1999, is hereby further amended to read in its entirety as follows:

H. Construction of all the above improvements shall be completed by September 1, 2001.
