SUBJECT: School Busses Parking in Residential Neighborhoods

Introduction

During the month of March, the police department received a complaint about a school bus parking on Washington Street east of Main Street. This is a residential neighborhood. Upon investigating the complaint, it was learned that the school bus was not in violation of any parking restrictions or zoning regulations. The presence of the bus caused concern for at least one neighbor who reached out to both Trustees Fitzpatrick and Breen. Specifically, Trustee Breen inquired as to what legislative remedies might be possible to deal with situations such as these in the Village.

Background

This is not the first time Village staff or elected officials have discussed this issue. On September 12, 2000, then Trustee Richard Tross brought the issue up for discussion at a meeting of the Transportation & Safety Committee following some complaints about school busses parking on the street as well as in private driveways in residential neighborhoods (see attached Exhibit "A"). At the time this discussion occurred, the parking of busses on the street would have been regulated only by parking restrictions applicable to the street, just as it is today. However, the parking of school busses in residential driveways was prohibited as a nuisance and was treated as a code enforcement / zoning violation. The Transportation and Safety Committee reached a consensus to allow the parking of school busses in residential neighborhoods subject to some setback provisions and only during the day.

This change was contemplated by the Village Board at its meeting of September 21, 2000. An ordinance to reflect the changes discussed at the Transportation & Safety Committee was prepared by the Community Development Department. However, the Community Development Department also indicated in their cover memorandum that they were not supportive of school busses being parked in residential areas at any time and that school busses should be returned to the bus depot yard when not in use (see attached Exhibit "B"). According to the Village Board meeting minutes, Trustee Tross

reported the findings of the Transportation & Safety Committee meeting to the entire Village Board. The Village Board was divided on the issue. Following discussion, a motion was made to deny the ordinance (supporting the staff position) which failed 4-2. A subsequent vote approved the ordinance amending Chapter 94, Section 94.04(L)(1) of the Village Code by a 5-1 vote (see attached meeting minutes, Exhibit "C" and Ordinance #4870, Exhibit "D" respectively).

Recommendation

The only substantive changes to the Village Code have only regulated the parking of school busses on residential property. The parking of school busses on residential streets has never been prohibited unless appropriate signage was in place otherwise restricting parking. Arguably this is more an issue of aesthetics than it is public safety. The resident on East Washington expressed a concern for home values because of the bus being there. While there may be an occasional sight line issue depending on where a bus is parked, the same would hold true for any large vehicle parked on the street in a residential neighborhood.

Given the fact that there is a renewed interest in this topic, I would recommend that the issue be forwarded to the Transportation & Safety Committee to again review. It has been nearly thirteen years since the issue was looked at and it may be appropriate to revisit and see if there is a different perspective or alternative solutions. I have also attached a copy of the current Village Code as Exhibit "E" for reference purposes. School Busses: Tross - I personally received three complaints about school busses. In Trustee Sebby's district - it is a complaint of code enforcement. A resident parks a school bus on her private property/she can take her school bus and park on Grace, legally, blocking View. Her issue is why can't I park a school bus on my driveway? Code enforcement states that what is prohibited is vehicles designed to carry more than 10 passengers. 2nd complaint is from Trustee Florey's district - resident parking bus on street and neighbors would like them to park on driveway. 3rd complaint is resident on Harrison that has a small bus, and neighbor will not allow her to park on double divider. Wants to park about a block away in "No Parking, School" area. I suggested that if she got the school bus with the handicap sticker, handicap sticker takes precedent. Bergeron - I would rather see the bus parked in the driveway instead of on the street. Schwarz - I would rather see them bring the bus back to a parking area and get their private car. Tross - time in between shifts is about an hour, which is not enough time to do this and complete their shifts. They are allowed to park on the streets, if it doesn't block any vision during the day (not at night). Johnson - is a school bus considered commercial? Tros - yes, according to code enforcement staff. Bedard - What is wrong with parking in the driveway? Tross - she doesn't want to pull the big bus in her driveway. Secretary of State does not consider school busses commercial vehicles. They have completely separate standards than other busses. Gron - is our ordinance different from the State ordinance? Tross - yes. Gron - then I would like to see it changed. Tross - is it the con census of the committee that if you can put a school bus on your driveway, as long as it is not overnight or on the weekend, it is okay? If totally on the driveway and not a safety issue at all, should be okay? Cuny - we know what they are doing. The concents of the committee was that this would be appropriate.

Millette - I will be attending an information study tomorrow in Wheaton for Rte, 53. Tross - should be right in/right out everywhere except Madison. Johnson - should be signalized at Madison; this is the only collector. Tross - also address Meadow issues (protected left turn lene). Johnson - need to collect some information from some residents, I do not have enything ready for this.

Schwarz - I will not be able to attend on 10/3. I am having surgery on 10/04. Tross - we will not meet in October, and will meet next on Nov. 7th.

AN ORDINANCE AMENDING TITLE 9, CHAPTER 94, SECTION 94.04(L)(1) OF THE LOMBARD VILLAGE CODE IN REGARD TO NUISANCES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 9, Chapter 94, Section 94.04(L)(1) of the Lombard Village Code is amended by adding the following to the end thereof:

"however, the parking of a school bus, as defined by 625 ILCS 5/1-182, shall not be prohibited between 8 a.m. and 4 p.m., provided the occupant of the residential property is the authorized driver of said school bus;"

Community Development Commission - Trustee David N. Schaffer,

Trustee Tross said the Committee had also ded signage requests from Madison and Hammerschmidt Schools, "No Parking" on was lage between Westmore/Meyers Road and converting of Yield signs to stop signs at whote and Taylor. In the matter of Route 64 and West Road the Committee mended no further action. Tross asked that a Waiver of first reading be approved on The ordinances representing these recommendations D,E, F,G,H and I. He added The future North Avenue Frontage Road at Route 53 is being discussed with regard to witing the Frontage Road at Route 53. The Committee will forward their minimendations in the next 4 months. Student driving and Driver's License testing in Littlet 6 has been questioned and the Lombard Secretary of State Station Manager will to the Committee to explain the facility's procedures. He said the Committee also Gillied school busses parking temporarily on residential property, which is on tonight's The feeling is that it is safer not to have the busses parked in the street providing grare not blocking the clear sight distance.

Ordinance 4870 School Bus Parking

An Ordinance amending Title 9, Chapter 94, Section 94.04(L)(1) of the Lombard Village Code to allow the temporary parking of a school bus on residential property. (DISTRICTS - ALL)

Trustee Sebby commented that he is concerned that the Village Code allows parking in the street and yet not temporarily in a resident's driveway.

Trustee Borgatell said that the drivers should leave the bus at the terminal and not bring the bus home.

Trustee Kufrin agreed that they should take them back to the terminal and deny the ordinance. Trustee Kufrin moved that the Board concur with the recommendation of staff to deny the ordinance to prohibit parking of school busses in residential driveways, The motion was seconded by Trustee Borgatell.

Trustee Tross said that this started as a home occupation issue and now they have complaints in all districts. He explained that the reasons that they are not taking the busses back to the terminal are to save gas and the drivers do double duty with the varying hours of all the different schools and have very little time in between. He said that there are concerns with stop signs being blocked from view, plowing issues and sight line problems. He requested that the Board allow daytime parking of busses in driveways and not in the Streets.

After some additional comments of the various Trustees, Trustee Schaffer called for the question.

It was moved by Trustee Paul Kufrin Jr, seconded by Trustee Ralph Borgatell, that the Board concur with the recommendation of staff to deny an amendment to Title 9, Chapter 94, Section 94.04(L)(1) of the Lombard Village Code to allow the temporary parking of a school bus on residential property.. The motion Failed by the following vote:

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 9, Chapter 94, Section 94.04(L)(1) of the Lombard Village Code is amended by adding the following to the end thereof:

"however, the parking of a school bus, as defined by 625 ILCS 5/1-182, shall not be prohibited between 8:00 a.m. and 4:00 p.m., provided:

- (a) the occupant of the residential property is the authorized driver of said school bus; and
- (b) the school bus is parked no closer than fifteen (15) feet from the sidewalk adjacent to said residential property or, where no sidewalk exists, no closer than fifteen (15) feet from the street adjacent to said residential property;"

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

§ 94.04 SCHEDULE A: NOTICE REQUIRED; NUISANCES DEFINED.

Notice must be given as set forth in § 94.03 for those nuisances defined as follows:

- (A) To use or occupy any part of a street, parkway, alley, or sidewalk of the village for the purpose of carrying on, soliciting, or promoting any trade, business, or other enterprise which impedes, interferes with, or makes dangerous travel thereon; also, to cause or permit the storage of any product, supplies for, or equipment incidental to the operation of such business or enterprise upon any street, parkway, alley, or sidewalk within the village;
- (B) (1) To create or permit to be created or remain upon any premises within the village for a period of more than 30 days, the storing, piling, scattering, accumulating, heaping, amassing or collecting of bricks, concrete blocks, straw, lumber, structural iron, pipe, roofing materials, or any building materials where the same is in public view and where the same may or does constitute a safety hazard to children playing in the area, or that may or does become an attraction to or haven for vermin or rodents.
- (2) Building material stored outdoors on any site for construction authorized by a building permit shall not be permitted to remain more than 30 days after completion of construction upon a job site;
- (C) To allow, cause, or permit garbage, rubbish, or waste materials to be set out in containers which are not covered, which permit or allow the contents of such containers to be accessible to rodents or animals, or that permit the contents thereof to be scattered or blown about:
- (D) For any person to dump, deposit, store, or place any garbage, rubbish, trash, or refuse upon

property within the village, except in covered containers;

- (E) To keep, shelter, feed, harbor, care for, maintain, or trap, or cause or permit to be kept, sheltered, fed, harbored, cared for, maintained or trapped, any animal on property within the Village except in full compliance with Chapter 90 of this Code.
- (F) (1) To store, cause to be stored, or permit to remain in public view on any premises within the Village, inoperable motor vehicles, not located within a garage. For the purpose of this subsection, "inoperable motor vehicle" means any motor vehicle from which, for a period of at least seven (7) days, the engine, wheels or other parts have been removed or on which the engine, wheels or other parts have been altered, damaged or otherwise so treated that the vehicle is incapable of being driven under its own motor power or one that for any period of time has been rendered inoperable because it does not have evidence of registration as required by 625 ILCS 5/3-701 et seq., or one which does not display a current license as required by Chapter 70 of the Village Code.
- (2) To deposit upon any public or private roadway, alley, driveway, parking area, or other place within the village limits, any inoperable motor vehicle or part thereof, without first obtaining permission of the owner, occupant, or agent of private property, or the Police Department of the village for public property;
- (G) To cause or permit the carcass of any dead animal or vegetable matter, slops, swill, suds, garbage, filth, stable drippings, or other offal or noisome substance of any kind including cat or dog feces to be collected, deposited, or remain in any place, yard or pen except in approved covered containers, and then only long enough to be properly disposed of;
- (H) To keep or permit to be kept upon any premises within the village any dog or other animal

or fowl emitting loud, frequent, and continuous offensive noises;

- (1) To cause or permit any premises within the Village to become or remain littered with tin cans, glass jars, bottles, scrap glass, paper cartons, scraps of paper, boxes, ashes, iron, old hot water tanks, oil storage tanks, tin or other metal materials, refuse, rubbish, junk, waste, manure, straw, landscape waste as defined by Section 92.41(E) of this Code, lumber, old bricks, concrete blocks, chunks of broken concrete, plaster board, discarded furniture, household appliances, mattresses, bed springs, portable swimming pools in disrepair, tires, or other like matter of things;
- (J) To corrupt or permit to be corrupted any water stream or source thereof;
- (K) To obstruct any water source, ravine, or gutter so as to cause water to stagnate therein, or to permit foul or stagnant water to stand upon any premises;
- (L) (1) All parking and/or storage of commercial vehicles requiring more than a Class B license plate as established by the Office of the Secretary of State of the State of Illinois such as trucks, tractors, and trailers on residential property; however, the parking of a school bus, as defined by 625 ILCS 5/1-182, shall not be prohibited between 8:00 a.m. and 4:00 p.m., provided:
- (a) The occupant of the residential property is the authorized driver of said school bus; and
- (b) The school bus is parked no closer than fifteen (15) feet from the sidewalk adjacent to said residential property or, where no sidewalk exists, no closer than fifteen (15) feet from the street adjacent to said residential property;
- (2) Storage of all other specialized commercial vehicles such as tractors, plows, backhoes, or any other similar equipment stored on any residential property unless said equipment is

garaged, or for a construction site for which a building permit has been issued.

- (M) To direct, allow or permit the flow of water from any downspout, sump pump, drain tile or any other artificial storm, ground or surface water drainage mechanisms or conduits onto a sidewalk or street so as to cause icing to exist on said sidewalk or street as a result of said water drainage. In the event that the nuisance described in this subsection is not corrected upon receipt of the notice referenced in Section 94.03 of this Code, and the Public Works Department is required to de-ice any street referenced in said notice a second or further time, the owner/occupant of the property in question shall, in addition to any fine that may be assessed for said Village Code violation, be billed for the actual costs incurred by the Village for the Public Works Department's performance of the de-icing.
- (N) To fail to maintain or repair any private stormwater management facility including, but not limited to, any private stormwater retention basin, detention basin or storm sewers, as well as any grates, inlets, outlets, manholes, catch basins or restrictors relative thereto, thereby creating a situation in which said stormwater management facility does not perform as designed or poses a potential or real hazard to the health, safety or welfare of the public.
- (O) The storage of firewood on a residential property:
 - (1) in an amount exceeding one-hundred twenty eight (128) cubic feet, also known as one full-cord;
 - (2) to a height greater than four (4) feet from grade;
 - (3) greater than eight (8) feet in width; or
 - (4) infested with vermin or rodents.
