100225; Ordinance Establishing No Parking Zones and Expanding Times for Existing One-Way Traffic on Streets Surrounding Westmore School

On June 7, 2010, the Transportation and Safety Committee continued their discussion of a traffic plan submitted by Mr. Dominic Sepich, Principle of Westmore School, along with several members of a concerned group of parents and teachers, at the previous T&S Committee. The proposed traffic plan, a collaborative effort between the Westmore School representatives and Public Works/Police staff, was designed to provide a more orderly and safe vehicle traffic pattern around the school during student drop-off and pick-up times. The plan requested modifications to the Village Traffic Code by expanding the effective time for one-way traffic on School Street and Ahrens Avenue, along with additional restricted parking on Division Street, Washington Street, and Ahrens Avenue.

After the presentation of this plan on May 3, 2010, Staff was directed to contact all affected homeowners to obtain their input on the proposed Traffic Code modifications. A survey was mailed to 64 homes. Three (3) responses were received between May 4, 2010 and May 31, 2010. Two (2) of the responses were concerned with the already too restrictive on-street parking. All of the responses were supportive of the proposed one-way time extensions. Based upon this information, the Committee voted to recommend the traffic plan for implementation. This action requires an ordinance to the Village Traffic Code as follows.
