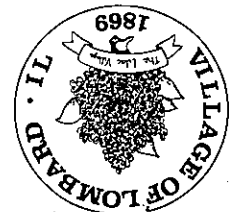

SUBJECT: Liquor License - Haveli

On January 20, 2006 the Board of Trustees approved a liquor license for Shakti05 Restaurant Inc. d/b/a Haveli located at 530 E. North Avenue, Lombard. As of today's date Haveli has not obtained a State liquor license nor have they begun to sell alcohol at their establishment.

According to Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code, "Any available license which is applied for by a licensee and granted shall be used within 30 days of the date the license has been granted. In the event the license is not used, for a period of 30 days ... the Local Liquor Control Commissioner shall notify in writing, the Village Clerk and the Board of Trustees of the ... non-use and shall cause to have the license number in the category reduced." Please find attached an Ordinance reflecting a decrease in the Class K liquor license category.

RE: Village of Lombard Liquor License

Dear Mr. Kollappalli:

It has been brought to my attention that you have not obtained a State Liquor License for your business, Haveli. The Village of Lombard issued a Local Liquor License to Shakti05 Restaurant Inc. d/b/a Haveli on January 20, 2006.

In this regard, pursuant to Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code, in regard to liquor licenses, "Any available license which is applied for by a licensee and granted shall be used within 30 days of the date the license has been granted. In the event the license is not used, for a period of 30 days ... the Local Liquor Control Commissioner shall notify in writing, the Village Clerk and the Board of Trustees of the ... non-use and shall cause to have the license number in the category reduced." You have not begun to sell alcohol nor have you obtained your State Liquor License as of March 17, 2006. As such, pursuant to this written notice, I am officially declaring your Village of Lombard Liquor License number 06-5332 null and void for non-use for more than 30 days..

ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code
is amended by revising the entry relative to the Class K liquor license, contained therein, to read
as follows:

“Class K - 1”

This decrease in the number of Class K liquor licenses is as a result of the fact that Shakti05
Restaurant Inc d/b/a Haveli, located at 530 E. North Avenue failed to obtain a State liquor license
and begin to use the Class K liquor license issued to it within 30 days of the approval of the
liquor license as required by Title 11, Chapter 112, Section 112.13(A) of the Lombard Village
Code.

Section 2: This Ordinance shall be in full force and effect from and after its passage and
approval as required by law.
