The Village published an invitation to bid on August 21, 2024 for the removal of snow and ice from walking surfaces in and around the train station and routes to schools. The Village received zero (0) bids for the proposed contract. Staff has contacted several contractors to solicit quotes for performing the work included in the contract. Godoy Snow Removal Inc. submitted the lowest proposal cost for the services under the contract language.

Staff is recommending the rejection of this bid process and seeks the approval of the proposal from Godoy Snow Removal Inc. in the amount not to exceed \$49,400.00. The current budgeted amount for this season is \$30,700.00

Witnesseth That in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to perform the services and the Village agrees to pay for the following services as set forth in the Contract Documents:

Snow and Ice Removal for areas indicated by map in contract documents

1. This Contract shall embrace and include all of the applicable Contract Documents listed below as if attached hereto or repeated herein:
 - a. Specification and Contract Document no. PWO-2416 for Snow and Ice removal, consisting of the following:
 - i) Cover Sheet
 - ii) Table of Contents
 - iii) General Terms, Conditions and Instructions
 - iv) Specific Terms, Conditions and Instructions and Blue Prints
 - v) Bid Proposal Form
 - vi) Plans and Specifications and Specification Deviation Form
 - b. The Contractor's Proposal Dated September 14, 2024
 - c. Required Performance and Payment Bonds and Certificate of Insurance
2. The Village agrees to pay, and the Contractor agrees to accept as full payment for the services which are the subject matter of this Contract the total sum of the submitted and approved invoice for services requested, paid in accordance with the provisions of the Local Government Prompt Payment Act and the provisions of the Contract Documents.

- 3. Contractor shall not delegate the duties involved in the performance of the services which are the subject matter of this Contract without the written approval of the Village.
- 4. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.
- 5. Where the terms of this Contract conflict with the provisions of the Contract Documents, the Contract Documents shall be binding.

**VILLAGE OF LOMBARD
CONTRACT PROPOSAL**

Proposal for Contract Document Number PWO-2416

We hereby agree to furnish to the Village Sidewalk Snow and Ice Removal in accordance with provisions, instructions, and specifications of the Village for the prices as follows:

For the deicing, snow shoveling and/or snow blowing for all areas. This cost should include all labor and equipment to complete the job. **The De-Icing Materials, such as bulk rock salt, are supplied by the Village.**

Any amount of measurable snow or ice that has accumulated on the surface, and the contractor was required to treat, will be considered as 1 inch against the total for the season. Any measurable snow that is not required to be treated by the contractor will not be considered as part of the total for the season.

Price shall be for up to 26 inches of snow or Ice as measured by the National Weather Service Station, Glen Ellyn from October 15th to May 31st of contract year.
