

ORDINANCE NO. 5336

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to delete the following therefrom:

Name of Street Shall Stop At Name of Street

Ridge Avenue, north & southbound

Sunset Avenue

Section 2: That Schedule III of the Lombard Traffic Code (Ordinance 1186) entitled STOP INTERSECTIONS be amended to add the following thereto:

Sunset Avenue and Ridge Avenue

Section 3: That Schedule XII (a) of the Lombard Traffic Code (Ordinance 1186) entitled PERMIT PARKING ZONES be amended to revise and add the following:

Vehicles parked in those parking lots referenced in Schedule XII (a) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

Section 4: That Section 10-13-22 (e) of the Lombard Traffic Code (Ordinance 1186) entitled MUNICIPAL PARKING PERMITS be amended to revise and add the following:

(e) Vehicles parked in those parking lots referenced in Schedule XII (a) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December

Section 5: That Schedule XII (b) of the Lombard Traffic Code (Ordinance 1186) entitled DAILY FEE PARKING ZONES be amended to add the following thereto:

In accordance with Section 10-13-14, daily fee parking zones are described below. The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of

May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

East Parkside Avenue Lot: north side from Charlotte Street to Martha Street

West Parkside Avenue Lot: north side from Park Avenue to Elizabeth Street

DuPage Theatre Lot: south parking lot

Section 6: That 10-13-14 (a) of the Lombard Traffic Code (Ordinance 1186) entitled PARKSAFE FEES AND TIME LIMITS; USE OF PROCEEDS be amended to revise the following:

(a) The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

Section 7: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
