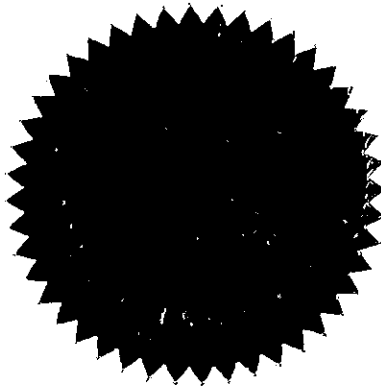

ORDINANCE 4403

**AN ORDINANCE ADOPTING A NEW COMPREHENSIVE PLAN  
FOR THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS**

(PC 97-22: Comprehensive Plan)

WHEREAS, the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois find as follows:

FIRST, the Plan Commission of the Village of Lombard conducted public hearings on September 10, 1997 and September 29, 1997 to consider the adoption of the proposed new Comprehensive Plan;

SECOND, the Plan Commission of the Village of Lombard has recommended the acceptance of the proposed new Comprehensive Plan; and,

THIRD, the Village of Lombard Board of Trustees concurs with the Plan Commission's recommendation regarding the adoption of the new Comprehensive Plan;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois:

SECTION 1: That the Comprehensive Plan document attached hereto as Exhibit "A" and made part hereof, as prepared for the Village by Trkla, Pettigrew, Allen and Payne, Inc., is hereby adopted as the official Comprehensive Plan of the Village of Lombard, DuPage County, Illinois.

SECTION 2: That all other ordinances adopting prior Comprehensive Plans, or any ordinances amending said prior Comprehensive Plans, are hereby repealed to the extent not previously repealed by other ordinances adopted by the Village Board.

SECTION 3: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.



ORDINANCE NO. 4404

AN ORDINANCE AMENDING TITLE 15, CHAPTER 155, SECTION 155.402  
OF THE LOMBARD VILLAGE CODE IN REGARD TO THE  
VILLAGE OF LOMBARD ZONING MAP

WHEREAS, the Lombard Plan Commission held public hearings, pursuant to proper notice, relative to the Village's Comprehensive Plan on September 10, 1997 and September 29, 1997; and

WHEREAS, pursuant to recommendation made by the Plan Commission, the Village Board adopted the Comprehensive Plan on January 22, 1998; and

WHEREAS, pursuant to 65 ILCS 5/11-12-6 and 5/11-12-7, an Official Zoning Map for the Village was included as part of said Comprehensive Plan; and

WHEREAS, the Official Zoning Map as approved was printed on January 14, 1998; and

WHEREAS, with the approval of a new Official Zoning Map, it is necessary to update the reference thereto in the Village Code;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 15, Chapter 155, Section 155.402(A) of the Lombard Village Code is amended by revising the reference therein to "April 1990" to read "January 1998."

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.



