**AN ORDINANCE EDITING SECTION 152.01 REGARDING THE  
COMPREHENSIVE PLAN**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Planning Ordinance, otherwise known as Title 15, Chapter 152 of the Code of Lombard, Illinois; and,

WHEREAS, the Board of Trustees deem it reasonable to periodically review said Code and make necessary changes; and,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Title 15, Chapter 152, Section 152.01 of the Lombard Village Code shall be amended to read as follows:

(A) The comprehensive plan of the village, which plan has been ~~prepared and was recommended on May 24, 1984 to the village,~~ is **adopted May 15, 2014 by Ordinance 6947** and made the official plan of the village, hereinafter designated as the official plan.

(B) ~~The southwest sub-area plan update~~ **Lombard Village-wide Bicycle and Pedestrian Master Plan, adopted February 18, 2018 by Ordinance 7192** is hereby incorporated by reference and made part of the comprehensive plan.

~~(C) The northwest sub-area plan update is hereby incorporated by reference and made part of the comprehensive plan.~~

~~(D) The Roosevelt Road corridor study is hereby incorporated by reference and made part of the comprehensive plan.~~

SECTION 2: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
