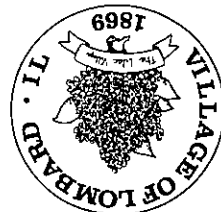

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 12
OF THE LOMBARD VILLAGE CODE IN REGARD TO THE
CREATION OF A NEW CLASS "FF" LIQUOR LICENSE**

ORDINANCE NO. _____

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

Section 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding the following thereto:

"Class "FF" – Package sales of beer and wine only, as an adjunct to general retail sales."

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding the following to the list of available licenses:

"Class "FF" - 1

That the change in the number of FF liquor licenses set forth in Section 1 above, is a result of granting a liquor license to Sears, Roebuck and Company doing business as The Great Indoors located at 2860 S. Highland Ave., Lombard

Section 3: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding the following to the list of semi-annual license fees:

"Class "FF" - \$1000.00"

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
