BACKGROUND/POLICY IMPLICATIONS:

Attached is an ordinance levying and assessing taxes for Special Service Area Number Three. The special service area, which was established for the property owners served by the traffic signal at 800 E. Roosevelt Road, provides them with a convenient method of paying the maintenance and operating costs of the signal. In order to pay these costs, the Board of Trustees must levy and assess the tax each year. This ordinance establishes the 2007 levy based on estimates provided by the Illinois Department of Transportation and the Finance Department.
