SUBJECT: **Text Amendment to Title 11, Chapter 112, Section 112.13(A)**
Number of Authorized Liquor Licenses – Class “C”
Buona Beef – 498 E. Roosevelt Rd

Buona Beef LLC d/b/a Buona Beef located at 498 E. Roosevelt Road currently holds a Class “C” liquor license which allows them to serve beer and wine as an adjunct to food service with no packaged sales. On January 25, 2021 staff received a letter from the managing member of Buona Beef LLC indicating that Buona Beef would cease doing business, effective at the close of business, on January 31, 2021 and are voluntarily relinquishing their liquor license effective February 1, 2021.

In response to that request, attached is an ordinance decreasing the Class “C” liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the Class “C” liquor classification current to reflect this change.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor licenses contained therein, to read as follows:

Class "C" - 6

That the decrease in the number of Class "C" liquor licenses as set forth in Section 1 above, is a result of Buona Beef LLC d/b/a Buona Beef located at 498 E. Roosevelt Road, no longer conducting business.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
