Establishing No Parking Zones and Expanding Times for Existing One-

Way Traffic on Streets Surrounding Westmore School

At the May 12, 2010 T&S Committee Meeting, a traffic plan was presented by Mr. Dominic Sepich, Principle of Westmore School, along with several members of a concerned group of parents and teachers. The proposed traffic plan, a collaboration between the Westmore School representatives and Public Works/Police staff, was designed to provide a more orderly and safe vehicle traffic pattern around the school during student drop-off and pick-up times. The plan requested modifications to the Village Traffic Code by expanding the effective time for one-way traffic on School Street and Ahrens Avenue, along with additional restricted parking on Division Street, Washington Street, and Ahrens Avenue.

After the presentation of this plan, Staff was directed to contact the adjacent homeowners to obtain their input on the proposed Traffic Code modifications. Attached is an example of the correspondence sent to the residences adjacent to the Westmore School. Also attached is a list of addresses the correspondence was sent and their recorded responses. Of the 64 homes contacted, 3 responses were received. Two (2) of the responses were concerned with the already too restrictive on-street parking. All of the responses were supportive of the proposed one-way time extensions. Based upon this information, staff recommends the following modifications to the Village Traffic Code:

- 1. Prohibit parking between 7:30am and 8:30am, and 2:30 pm and 3:30 pm on school days at the:
 - a. North side of Washington Street from Ahrens Avenue to a point 90 feet east; and
 - South side of Division Street between Ahrens Avenue and School Street;
 and
 - c. West side of School Street from Division Street to a point 135 feet south.
- 2. Extend the hours of existing one-way traffic designations from 8:00 am to 3:00 pm on school days to 7:30 am to 4:00 pm on school days at:
 - a. Ahrens Avenue from Washington Boulevard to Division Street; and
 - b. School Street from Division Street to Washington Boulevard.

The Village of Lombard and Westmore School have been collaborating on methods to improve traffic congestion and pedestrian safety in your neighborhood. School, Police, and Public Works representatives have developed a traffic plan/policy that we believe will increase the safety of all pedestrians, students, and the motoring public. 
Implementing the plan will require additional "No Parking Zones" and expand the time of the current one-way traffic limitations on Ahrens and School Streets. The proposed changes to the Traffic Code are:

- 1. Prohibit parking between 7:30 am and 4:00 pm on school days at the:
 - a. South side of Division Street between Ahrens Avenue and School Street; and
 - b. West side of School Street from Division Street to a point 135 feet south.
- 2. Prohibit parking between 2:30 pm and 3:30 pm on school days at the:
 - a. North side of Washington Street from Ahrens Avenue to a point 90 feet east.
- 3. Extend the hours of existing one-way traffic designations from 8:00 am to 3:00 pm on school days to 7:30 am to 4:00 pm on school days at:
 - a. Ahrens Avenue from Washington Boulevard to Division Street; and
 - b. School Street from Division Street to Washington Boulevard.

If you have any comments, please contact us before May 31, 2010. This issue will be discussed at the next Village Transportation and Safety Committee meeting on June 7, 2010 at 7:00 pm in the Village Hall Community Room.
