

**ORDINANCE NO. 7872**

**AN ORDINANCE AMENDING TITLE IX, CHAPTER 94  
OF THE LOMBARD VILLAGE CODE IN REGARD TO  
VIOLATIONS OF GUBERNATORIAL EXECUTIVE ORDERS,  
IN LIGHT OF THE COVID-19 PANDEMIC**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title IX, Chapter 94 of the Lombard Village Code is amended by adding a new Section 94.26 thereto, which shall read in its entirety as follows:

**"§ 94.26 Violations of Gubernatorial Executive Orders.**

(A) Violations of any Executive Order issued by the Governor of the State of Illinois, in furtherance of any Disaster Proclamation issued by the Governor of the State of Illinois relative to the COVID-19 pandemic (a "COVID-19 Executive Order"), are hereby declared a public nuisance. It shall be unlawful for any person (as defined in Section 10.05 of this Code) to violate any COVID-19 Executive Order issued by the Governor of the State of Illinois.

(B) Any person (as defined in Section 10.05 of this Code) found guilty of violating subsection (A) above shall be fined not to exceed \$750.00, and each day that a violation of subsection (A) above exists shall constitute a separate and distinct offense."

**SECTION 2:** That, in light of the fact that Executive Order No. 2020-08 of the Village President, covering the topic of this Ordinance, will terminate as of the adjournment of the October 15, 2020 Village Board meeting, and, therefore, the provisions of this Ordinance need to take effect immediately upon the passage and approval of this Ordinance, so as to keep the provisions set forth in said Executive Order No. 2020-08 in effect, this Ordinance shall be in full force and effect from and

after its passage and approval by a two-thirds (2/3rds) vote of the members of the Corporate Authorities holding office as of the date of this Ordinance, as provided by law.
